

# Data Protection Statement for Data Subjects Users of [www.crossinvest.ch](http://www.crossinvest.ch)

## Scope of Application

Pursuant to the Federal Act on Data Protection, this document provides information regarding the processing of personal data provided by Data Subjects users of [www.crossinvest.ch](http://www.crossinvest.ch) to achieve the purposes described below.

This document is not intended to apply to websites that can be reached through links on or cited in [www.crossinvest.ch](http://www.crossinvest.ch). This document may be modified at any time without notice.

## Definitions

The following are defined in this document:

**Personal data:** any information concerning an identified or identifiable natural person;

**Data subject:** the natural person whose personal data are being processed;

**Personal data worthy of special protection:**

1. data concerning religious, philosophical, political or trade union opinions or activities,
2. data concerning health, intimate sphere or membership in a race or ethnic group,
3. genetic data,
4. biometric data that uniquely identify a natural person,
5. data concerning administrative and criminal prosecutions and sanctions,
6. data concerning social welfare measures;

**Processing:** any operation concerning personal data, regardless of the means and procedures used, namely the collection, recording, storage, use, modification, communication, storage, erasure or destruction of data;

**Communication:** the transmission of personal data or making them accessible;

**Data controller:** the private individual or federal body that, individually or together with others, determines the purpose and means of processing;

**Data controller:** the private individual or federal body that processes personal data on behalf of the data controller.

## What personal data does [www.crossinvest.ch](http://www.crossinvest.ch) collect and purpose of processing

The website [www.crossinvest.ch](http://www.crossinvest.ch) collects data exclusively for storing data in log files that are indispensable for monitoring the proper functioning of the website itself and for the prevention or detection of cyber attacks. These are data that make the person identifiable only indirectly, such as the IP address or domain names of computers and terminals used by users, which are kept only for the time necessary to fulfill the purpose for which they were collected. Any legal requirements or other constraints may extend the length of retention.

The [www.crossinvest.ch](http://www.crossinvest.ch) website does not collect data for the purpose of tracking, analyzing behavior and profiling visitors. Please refer to the cookie policy document available at [www.crossinvest.ch](http://www.crossinvest.ch) for further details.

## Recipients of collected data

Personal data recorded by the [www.crossinvest.ch](http://www.crossinvest.ch) website are handled by the Data Processor for the management of the Infomaniak Network SA web platform exclusively for the purposes stated above.

## Data security

Data communication on [www.crossinvest.ch](http://www.crossinvest.ch) is done in a secure mode using the TLS protocol combined with the highest level of encryption supported by the user's browser. To know whether a web page is transmitted in encrypted form, simply check whether a key or closed padlock symbol appears in the address bar of the browser in use.
